Ronald W. Ruppert was elected Judge of the Franklin Municipal Court and began serving his term on January 1, 2018.

Our Mission

The Mission of the Franklin Municipal Court is to provide fair and impartial justice, enforce the rule of law, ensure public safety, protect the rights of individuals and to provide the residents of Franklin, Franklin Township and Carlisle a forum to resolve matters fairly and impartially.

Highlights and Procedural Improvements

- Partnership with Warren County Veterans Court has allowed the opportunity for veteran's to participate in a veteran focused recovery program supervised by Judge Gary Loxley;
 - A recent participant successfully completed the program and was awarded the certificate of graduation in Warren County Veterans Court. He was then successfully terminated from Franklin Municipal Court's order of probation.
- Implementation of E-Citations beginning December 2021 and reaching full implementation in 2022;
- Improvements to Court's website providing accurate information and ease of e-payments for the public;
- The Court, in collaboration with the Franklin Police Department, streamlined and updated pickup radius criteria relating to warrants in the Ohio Law Enforcement Automated Data System (LEADS), the National Crime Information Center (NCIC) and taking custody of wanted individuals;
- Franklin Municipal Court was the first court to implement an electronic transfer of felony cases to Warren County Common Pleas Court. This pilot program was successful and paved the way for the use of electronic transfer of felony cases from all Municipal Courts in Warren County to the Warren County Common Pleas Court;
- Installation of new printing systems for Deputy Clerks to improve efficiency and service to the public;
- Addition of virtual server and server migration for added information security and capacity for the implementation of electronic filings in 2023;
- Implemented electronic filing in July of 2022 in accordance with rules of Superintendence of the Courts of Ohio;
- Improved case flow management by improving information transfer with the City of Franklin PD, Warren County Jail and Warren County Sheriff's Office through email transfer of documents compared with outdated methods such as fax, regular mail or hand delivery;
- Continued Court security improvements;
- The Court implemented a more extensive budget review process allowing for more strategic planning;
- Began discussions and planning regarding improvements to Court facilities;
- The Court's Intensive Supervised Probation docket received a commitment from Warren County Career Center and private individuals for full adult education scholarships as determined by the Court upon graduation for the Intensive Supervised Probation docket.

Foreword



This report will summarize and highlight the operations of Franklin Municipal Court. The Court serves the communities of the City of Franklin, Franklin Township and the City of Carlisle. The Court employs a full-time Magistrate, full-time Clerk of Court, 6 Deputy Clerks of Court, 3 full-time Probation Officers, Chief Bailiff and Deputy Bailiff.

Beginning in 2021 and continuing throughout 2022, the Court updated equipment for Court staff, implemented new procedures, developed new processes to improve the working relationship between all Municipal Courts in Warren County and the Warren County Common Pleas Court and also implemented new procedures for communicating with law enforcement. In addition, 2022 saw the retirement of Clerk of Court, Sabrina Spence, the addition of Amanda Weist as Court Administrator and swearing in of Nikki Simpson as Clerk of Court.

Intensive Supervised Probation Docket

Magistrate Gregory Demos presides over the Intensive Supervised Probation Docket. The docket is designed to give criminal defendants with severe substance abuse disorders an opportunity to engage in drug and alcohol treatment while being closely monitored by the Probation Department and the Court. The goal is to have participants achieve long term sobriety; engage in employment and/or educational pursuits and become productive members of the community.


During the 2022 calendar year, 25 participants engaged in the Intensive Supervised Probation Docket known as Drug Court. 6 participants successfully completed the program and graduated. 7 participants were terminated from the program for noncompliance. 4 participants have absconded. The Probation Department has issued warrants and/or filed probation violations on those participants. 8 participants remain actively engaged in the program.

The Probation Department has issued warrants and/or filed probation violations for those that have absconded or were terminated from the program for non-compliance.

Total Fines, Cost and Fees

Franklin Municipal Court collects fines, court costs and fees. These funds offset operating costs and are distributed to the State of Ohio, Warren County, City of Franklin and Carlisle in accordance with state law. A small percentage of the collected funds are retained by the Court for funding special projects and other operational expenses.
